

# SECTION I: INSTRUCTIONS TO BIDDERS

### 1. Rights of Public Entity

The Ohangwena Regional Council reserves the right:

- (a) To split the contract as per the lowest evaluated cost per item, or
- (b) To accept or reject any quotation; and
- (c) To cancel the quotation process and reject all quotations at any time prior to contract award.

# 2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

- (a) The Quotation Letter in Section II with its annex for *Bid Securing Declaration*
- (b) The List of Goods and Price Schedule Section III;
- (c) The Specifications and Compliance Sheet in Section V; and
- (d) Any other attachment deemed appropriate.

You are advised to carefully read the complete Request for Sealed Quotations document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

### 3. Validity of Quotations

The Quotation validity period shall be 90 days from the date of submission deadline.

### 4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should:

- a) have a valid certificate of good standing with the Receiver of Revenue

# 7. Sealing and Marking of Quotations

Quotations should be sealed in a single envelope, clearly marked with the Procurement Reference Number, addressed to Ohangwena Regional Council with the Bidder's name and contact information at the back of the envelope.

## 8. Submission of Quotations

Quotations should be hand delivered in the bid box at the Reception of Water Supply and Sanitation Coordination Office, not later than the 26 January 2024 at 10:00. Quotations by post or hand delivered should reach by the same date and time at latest. Late quotations will be rejected. Quotations received by Fax or e-mail will not be considered.

## 9. Opening of Quotations

Quotations will be opened internally by the Ohangwena Regional Council immediately after the closing time referred to in instruction 8 above. At a bid Opening session, the name of the bidder, the total amount of each bid, any discount or alternative offered. And the preteens or absence of any bid securing if required. And the documents referred to in section 50(2), are read out and recorded, and a copy of the record is made available to any bidder on request.

## 10. Evaluation of Quotations

The **Ohangwena Regional Council** shall have the right to request for clarifications in writing during evaluation. Offers that are **substantially responsive** shall be compared on the basis of price or ownership cost, subject to Margin of Preference where applicable, to determine the **lowest evaluated quotation**.
