## SECTION I: INSTRUCTIONS TO BIDDERS

### 1. Rights of Public Entity

The **Ohangwena Regional Council** reserves the right:

- (a) To split the contract as per the lowest evaluated cost per item, or
- (b) To accept or reject any quotation; and
- (c) To cancel the quotation process and reject all quotations at any time prior to contract award.

### 2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

- (a) The Quotation Letter in Section II with its annex for ***Bid Securing Declaration***
- (b) The List of Goods and Price Schedule Section III;
- (c) The Specifications and Compliance Sheet in Section V; and
- (d) Any other attachment deemed appropriate.

**You are advised to carefully read the complete Request for Sealed Quotations document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.**

### 3. Validity of Quotations

The Quotation validity period shall be **90 days** from the date of submission deadline.

### 4. Eligibility Criteria

**The bidder or supplier must submit the following documents at the time of submitting a bid to a public entity, failing which the bidder or supplier must disqualified:**

- (a) a valid certificate of good standing with the Receiver of Revenue;

## 7. Sealing and Marking of Quotations

Quotations should **be sealed in a single envelope**, clearly marked with the Procurement Reference Number, addressed to **Ohangwena Regional Council** with the **Bidder's name and contact information at the back of the envelope**.

## 8. Submission of Quotations

Quotations should be deposited in the Bid Box located at the reception, **not later than 20 December 2024, Ohangwena Regional Council Office at 10H00**. Quotations by post, courier or hand delivered should reach **Ohangwena Regional Council Office** at Procurement Office by the same date and time. **Late quotations will be rejected**.

## 9. Opening of Quotations

Quotations will be opened internally at the **Ohangwena Regional Council Office** immediately after the closing time referred to in instruction 8 above. A record of the Quotation Opening as contemplated in Section 50 (2) of the Public Procurement Act, 2015 (Act No.15 of 2015) as amended will be available to any bidder on request and published on the Ohangwena Regional Council website eg portal or [www.ohangwenarc.gov.na](http://www.ohangwenarc.gov.na), at least three working days and / or when is practicable.

## 10. Evaluation of Quotations

The **Division Gender Equality Poverty Eradication and Social Welfare** shall have the right to request for clarifications in writing during evaluation. Offers that are **substantially responsive** shall be compared on the basis of cost price, determine **the lowest evaluated quotation**.

## 11. Technical Compliance
