1. Purchaser

The Public Entity inviting the Informal Quotation is the Purchaser for the purpose of entering into

2. Supplier

The Bidder having submitted the lowest price and whose offer is substantially responsive to the requirements specified shall be selected for award of contract and referred to as the Supplier.

3. Rights of the Public Entity

The Purchaser shall have the right to

- (a) Ask for clarifications at time of evaluating quotations,
- (b) Split the contract on an item basis or
- (c) Reject all quotations.

A Purchaser shall not be bound to accept the lowest or any quotation.

4. Eligibility Criteria

The bidder or supplier must submit the following documents at the time of submitting a bid to a public entity, failing which the bidder or supplier must disqualified:

- a valid certificate of good standing with the Receiver of Revenue; (a)
- a valid certificate of good standing with the Social Security Commission or, in the (b) case where a company has no employees, confirmation letter from the Social Security Commission;
- As required by the Affirmative Action (Employment) Act, 1998 (Act No. 29 of (c) (i)
 - a valid affirmative action compliance certificate issued under section 41 of
 - an exemption issued under section 42 of that Act; or (ii)
 - a proof from the Employment Equity Commissioner that the bidder or (iii) supplier is not a relevant employer as defined in that Act;

- certificate of business registration for an entity incorporated or registered (i) under the company or close corporation laws of Namibia;

- document serving as evidence of registration as a trust and the trust deed for a trust registered under the laws regulating trusts in Namibia; or

6. Prices

Prices shall be quoted in Namibian dollars. Prices quoted shall be firm and fixed during validity period of quotation and for execution of contract.

7. The Contract

The letter of Acceptance/Purchaser Order Form as the case may be together with this Informal Quotation form shall constitute the contract between the Public Entity and the Supplier.

8. Purchase order

A supplier to whom a purchase order is issued must confirm the purchase order within three days of receipt of the purchase order and;

(a) may not change or alter the terms of the purchase order; and

(b) must undertake to deliver the goods on or before the date set in the purchase order for

(c) the purchase order shall be valid for 30 days only and will be cancelled thereafter.

General Conditions of Contract 9.

10. Warranty

- (a) The Supplier warrants that the goods shall conform to the standards, specifications and related services as defined by the Purchaser in its Invitation for Informal Quotation subject to any alternative proposal made by the Supplier in its response to the Purchaser's Invitation for
- (b) The Supplier undertakes to make good, at its own cost and promptly, any deficiency in the supply of goods items and related services.
- (c) The Supplier warrants that the goods items to be supplied are new and unused and that it shall attend promptly to any defect in the good items as per the warranty conditions mentioned in its offer.

11. Payment

The Purchaser undertakes to effect payment within 30 days after supply of the goods items to the satisfaction of the Purchaser and subject to the Supplier submitting all required documents. Final payment shall be adjusted to reflect any noncompliance in the execution of the contract.
